I am delighted to have served as the interim GCNMC Intern. I wish I had more time to explore and work on many more exciting projects. At about midterm of my one year interim position, I was honored to participate in national and international nuclear medicine meetings.

I have initiated a large retrospective study evaluating the role of the ventilation portion of V/Q scanning in screening for lung parenchymal disease. We are hoping this study will lead to a larger prospective study and ultimately to confirming the great usefulness of V/Q imaging in non-embolic disease. In the meantime, I continue to enjoy serving the GCNMC in outreach projects to educate the general public about the broader role of nuclear medicine, and particularly in cancer treatment planning and treatment.

AUC Guidelines Update

The Guidance Oversight Committee of the Society of Nuclear Medicine and Molecular Imaging is proud to announce the approval by the SNMMI Board of Directors of the first two SNMMI Appropriate Use Criteria (AUC) at the 2017 SNMMI Mid-Winter Meeting. These two documents will help guide referring physicians in caring for patients with suspected pulmonary embolism and patients with prostate and breast cancer. Once these documents are formatted for publication they will be made available on the SNMMI web site under the “Quality and Practice” tab on the home page, then under “Guidance”.

Soon to follow are two more AUC on Hepatobiliary Imaging and PET Imaging in Restaging Malignant Disease. We hope these two AUC will be ready for SNMMI Board of Director review at the April Board meeting.

The workgroups putting these four carefully researched and discussed documents together have volunteered many hours of their time and expertise to assure that these documents meet the standards put forth by the Institute of Medicine for guideline development, and also include input from stakeholders from other specialty societies. These documents will be reviewed annually with updates issued (when appropriate) shortly after review.

The Guidance Oversight Committee is taking advantage of the momentum offered by the approval of these documents to begin development of six new AUC describing the use of I-123 and I-131 in the diagnosis and treatment of thyroid disease, prostate cancer imaging, somatostatin receptor imaging, white blood cell imaging of infection, imaging of gastrointestinal motility, and PET myocardial perfusion imaging.

The Guidance and Oversight Committee would like to thank SNMMI Leadership for their support of the development of these documents, and particularly thank the members of the workgroups that have volunteered so much of their time and efforts towards development of these AUC. The documents will be a valuable resource for referring physicians and ultimately improve the care of our patients.
