1. Call to Order

- a. Quorum was established.
- b. Minutes from January 29, 2016 were approved with no changes.
- c. Reviewed Action Items
 - i. An invitation to join the group was extended to Lisa Bodei but no response has been received; J. Mailman will send another, S. Hedrick will forward the previous invitation to him.
 - ii. ASCO – The group is in favor of pursuing a session at the 2017 GI meeting, but not the GU meeting. E. Mittra will take the lead and send in the proposal; A. Loaiza-Bonilla will assist him if needed. Combining efforts with the PET COE was discussed for the area of prostate imaging at the ASCO annual meeting and the 2018 GU meeting.
 - iii. Shane Anderson was discussed as a possible member of the group. He has spoken at AUA meetings for a number of years. S. Hedrick will invite him to join the group.
 - iv. B. Carney will send the edited Draximage video to the group for further review. It is being considered as a posting on the SNMMI Patient website.

2. Updates

- a. ASTRO
The SNMMI session proposal has been accepted. The exact date is TBD but will be during the Sept 2016 meeting. The topics are: PRRT (E. Mittra), Radium-223 (A. Sheikh) and Y90 therapies (G. El-Haddad).
- b. NANETS
There will be one session at the September NANETS 2016 meeting. The speakers will be Michael Graham, MD; Wolfgang Weber, MD; and E. Mittra.
- c. ASH
ASH had requested that imaging and therapy be separated in our proposal and although this was done, the proposal was turned down. The group felt that it was necessary to include therapy in the proposal and removing it would have been unfavorable but agreed that next year it might be necessary to remove RIT and focus on imaging.

3. Thyroid Subgroup

- a. Chapters
The SNMMI Southwest Chapter meeting was well attended. A. Avram and M. Tulchinsky spoke and generated good questions and reviews. They thought that the subgroup should do more education around pre-ablation scans.
- b. ATA
Two sessions have been approved for ATA 2016. A. Avram and H. VanBrocklin will be presenters on Sept 22nd. S. Hedrick will confirm that registration is being covered by ATA.
- c. Chapter Outreach
The group discussed holding roadshows or satellite sessions at the national meetings for ATA, AACE and ENDO. It was agreed that a CME webinar could reach non-nuclear physicians and that funds would be needed for mailing lists, etc. to promote the webinar. S. Hedrick and M. Tulchinsky will hold a call to discuss such a webinar.

4. Future Projects

- a. Thyroid: The group discussed the options of funding sessions at national meeting or satellite sessions. National meetings were more favorable because being on the schedule attracts more participants. It also enables mentions in the meeting highlights and abstracts. There was discussion about holding sessions at more general venues for medical oncologists, such as AACR. A surgeons group would be a good target, but ACP is not. S. Hedrick will research options and contact Gary Bloom.
- b. The group agreed that NET should be a major focus going forward.
- c. R. Atcher suggested that SNMMI work with the Commission on Cancer to see if we can propose a session on TRT topics. The information must be evidence based. This comment requires further discussion on the next conference call.
- d. A. Iagaru stated that he will be stepping down as chair of this group after the annual meeting in June. The group thanked him for his leadership. Any suggestions or volunteers to replace him should be forwarded to SNMMI leadership in time for them to discuss before June.
